MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objectives and Strategies

The investment objective of the Educators Monitored Conservative Portfolio (the "Fund") is to provide income with some potential for low to moderate capital growth. It does this by maintaining a balance of investments across several asset classes. The Fund invests primarily in mutual funds that invest in securities of Canadian and foreign governments and corporations. The asset mix is varied depending on the outlook for the economy and financial markets. The fundamental investment objective of the Fund may not be changed without the prior approval of the unitholders.

Risk

The risks of investing in the Fund remain as discussed in the Simplified Prospectus. Since inception of the Fund no changes affecting the overall level of risk of investing in the Fund were made to the Fund as at December 31, 2021.

The impact of the coronavirus (*COVID-19*) pandemic on the financial performance of the Fund's investments will depend on future developments, including the duration and spread of the outbreak and related advisories and restrictions. This public health crisis and the impact of *COVID-19* on the financial markets and the overall economy are highly uncertain and cannot be predicted. If the financial markets and/or the overall economy are impacted for an extended period, the Fund's future investment results may be materially affected.

Results of Operations

The Fund's net assets increased by 56.1% to \$84.3 million at the end of December 2021, up from \$54.0 million at the end of December 2020.

Investment Performance

For the year/period ending December 31, 2021 (the 'period'), the Educators Monitored Conservative Portfolio – Class A Series provided a return of 4.31% versus a Benchmark return of 4.45%. The Benchmark is a weighted composite consisting of 5.5% MSCI EAFE Index C\$, 6.5% S&P 500 Index C\$, 16.0% S&P/TSX Composite Index, 51.5% FTSE Canada Universe Bond Index, 15.5% FTSE Canada Short Term Bond Index, and 5.0% FTSE 91-Day T-Bill Index (the 'Benchmark').

The Fund underperformed its blended Benchmark over the period. Unlike the Benchmark, the Fund's return is net of fees and expenses paid by the Fund. Detailed performance is provided under the heading "Past Performance" in this report. Investors cannot invest in the Benchmark without incurring fees, expenses and commissions which are not reflected in Benchmark returns.

Class F units of the Fund were first offered by prospectus dated May 14, 2021. Due to policies issued by the Canadian Securities Administrators, investment performance data is not reported for funds in existence for less than one year.

2021 saw a very positive year for developed market equities, with returns supported by robust economic and earnings growth. In contrast, fixed income returns were negative, as investors looked ahead to policy normalization from major central banks.

Against this backdrop, the portfolio benefitted from a larger than Benchmark weight to Canadian and U.S. equities, as well as a lower than Benchmark weight to Canadian bonds during the period. Allocations to mortgages and global high-yield bonds added further value.

Meanwhile, the portfolio saw large contributions from security selection courtesy of the portfolio's Canadian bond and international equity segments. Also, Canadian equity stock selection modestly contributed to the portfolio's performance.

Recent Developments

The past two years stand out as one of the most turbulent times in modern history. Fortunately, the dramatic stimulus provided by most governments and central banks has helped produce a strong and rapid economic recovery. However, elevated commodity prices, social re-opening demand and supply imbalances, and a tight labour market, have all led to increased inflation expectations. This environment of strong growth, combined with higher pricing pressures, suggest that central bank officials may now remove monetary policy support earlier and faster than previously expected. Indeed, by the end of 2021, markets had pencilled-in expectations for rate increases of 75 basis points (0.75%) from the U.S. Federal Reserve and 125 basis points (1.25%) from the Bank of Canada in 2022. It will also be vital to monitor the impact of Omicron variant disruptions.

Nonetheless, the portfolio manager believes the economy remains in the expansion phase of the cycle and they currently run a modest bias towards risk assets. Continuing economic and corporate earnings growth suggests equity returns should still outperform bonds. However, with the robust performance seen in the recent past, the portfolio manager believes there is a need to be realistic about prospective near-term return expectations.

Towards the end of 2021, in recognition of shifting global financial conditions, the portfolio manager further reduced the Fund's exposure to emerging market assets. Within fixed income, they broadly continue to see value in corporate bonds relative to government debt. Regionally, the portfolio manager enters 2022 with a preference for the domestic equity market, with smaller overweight positions to U.S. and international equities.

Related Party Transactions

Pursuant to the Fund's investment strategies included in the Fund's Simplified Prospectus, the Fund may invest in other mutual funds and for the period has invested in various HSBC Funds which are funds managed by the Fund's Portfolio Manager. Please refer to the

In 2021 Educators Financial Group did not refer any conflict of interest matters to the Fund's Independent Review Committee (IRC) and accordingly did not rely upon any recommendation of the IRC in respect of any related party transactions.

Educators Financial Group is the Manager and Trustee of the Fund. Educators Financial Group is a wholly-owned subsidiary of the Ontario Secondary School Teachers' Federation (“OSSTF”). OSSTF may from time to time invest in units of the Fund.

⁽⁶⁾ The management expense ratio before waivers or absorptions shows what the management expense ratio of the Fund would have been if Educators Financial Group had not charged a lesser amount for its management fee.

⁽⁷⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁽⁸⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio manager manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.



Management Fees

Educators Financial Group is the Manager-Trustee, promoter, and principal distributor of the Fund, and is responsible for the day-to-day management and administration of the Fund.

The Manager-Trustee monitors and evaluates the performance of the Fund and pays for the investment management services of the portfolio manager, as well as all administrative services required by the Fund. As compensation for these services, Educators Financial Group is entitled to receive a fee, payable monthly and calculated daily, based on the Net Asset Value of the Fund, at the annual rate of 1.45% for the Class A Series, 1.16% for the Class E Series and 0.55% for the Class F Series. The Class I Series is identical in all aspects to the Class A Series, except that there is no management fee payable by the Fund in respect of the Class I units.

The Fund is responsible for paying any applicable tax owing on its management fee.

Approximately 15.1% of the total management fees collected from all Series were used to pay for portfolio management services, with the remainder of the fees being allocated to custodial services, marketing, technology, and Manager-Trustee operating expenses.

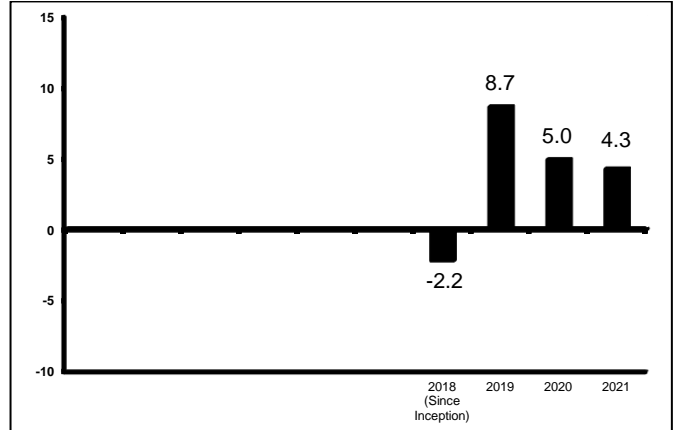

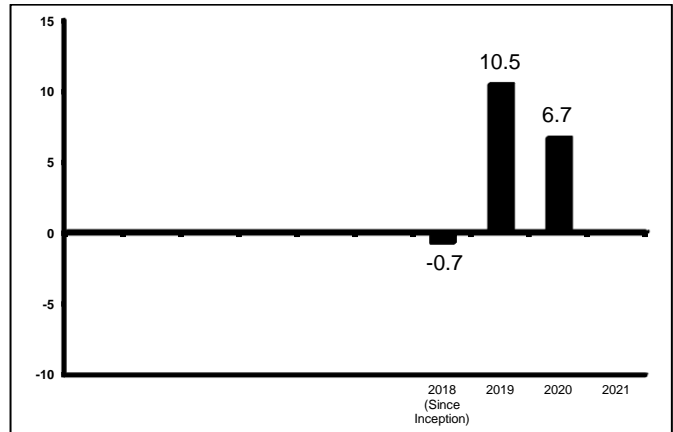
Year-by-Year Returns

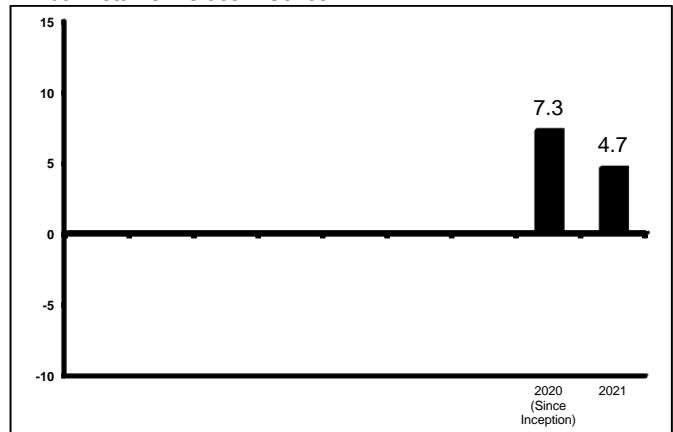
Annual Returns – Class A Series ⁽¹⁾

Annual Compound Returns

The following table compares the historical annual compound returns of the Fund with the performance of the blended Benchmark index comprised as follows: 5.5% MSCI EAFE Index C\$, a stock market index that is designed to measure the equity market performance of developed markets outside of the U.S. & Canada, 6.5% S&P 500 Index C\$, a stock market index based on the market capitalizations of 500 large companies having common stock listed on the New York Stock Exchange, 16.0% S&P/TSX Composite Index, a capitalization-weighted index designed to measure the market activity of some of the largest float adjusted stocks listed on the Toronto Stock Exchange, 51.5% FTSE Canada Universe Bond Index, which is a broad measure of the total return of Canadian bonds that mature in more than one year 15.5% FTSE Canada Short Term Bond Index, a market capitalization-weighted index consisting of a broadly diversified range of investment grade federal, provincial, municipal and corporate bonds with a term to maturity between one and five years and 5% FTSE Canada 91 Day T-Bill Index, which measures the performance attributable to 91-day Treasury Bills of the provincial and federal governments.
