### What does the fund invest in?

The fund invests mainly in the stocks of companies in substantially the same proportion as its benchmark index, either directly or indirectly through other investment funds (specifically, the TD International Equity Index ETF). The fund's benchmark is Solactive GBS<sup>®</sup> Developed Markets ex North America Large & Mid Cap CAD Index (CA NTR), an index calculated by Solactive AG, which tracks the performance of the large- and mid-cap segment covering approximately the largest 85% of the free-float market capitalization in the Developed Markets excluding North America.

# How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

# **Risk rating**

TDAM has rated the volatility of this fund as **medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

### How has the fund performed?

This section tells you how F-Series securities of the fund performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the fund's returns.

#### Year-by-year returns

This chart shows how F-Series securities of the fund performed in each of the past 10 completed calendar years. The fund dropped in value in 2 of the 10 years.

The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



#### **Best and worst 3-month returns**

This table shows the best and worst returns for F-Series securities of the fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

#### Average return

As of May 31, 2022, the annual compounded return of F-Series securities of the fund was 8.9% over the past 10 years. If you had invested \$1,000 in F-Series securities of the fund 10 years ago, your investment would now be worth \$2,347.

# **1** Sales charges

This series is available on a "no-load" basis which means that you do not pay a sales charge when you buy this series.

#### 2 Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2021, the fund's expenses were 0.34% of its average value. This equals \$3.40 for every \$1,000 invested.

#### Management expense ratio (MER)

This is the total of the fund's management fee and any expenses, costs or fees incurred by the fund which are not paid for by the manager.

Trading expense ratio (TER) These are the fund's trading costs.	0.04%
