**Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risk.**

**Effective on or about October 1, 2022, Mawer Investment Management Ltd. will replace Beutel, Goodman & Company Ltd. as portfolio manager of the Fund. As a result of the change, the management fee of the Fund will be reduced from 1.75% to 1.60% and the MER of the Fund is expected to be 1.80%.**

### What does the Fund invest in?


This Fund invests primarily in equity securities of established U.S. companies to provide long term capital growth.

### How Risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

#### No guarantees

Like most mutual funds, this Fund doesn’t have any guarantees. You may not get back the amount of money you invest.

### Risk rating

Educators Financial Group has rated the volatility of the Fund as **medium**.

This rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.





### How has the Fund performed?

This section tells you how the Class A units of the Fund have performed over the past 10 years. Returns are after Fund expenses have been deducted. These expenses reduce the Fund’s returns. On September 15, 2017 the Fund changed its investment objectives, changing from a North American equity fund to a U.S. equity fund. Had such changes been in effect throughout the past 10 years, the Fund’s performance could have differed materially from that shown below.

#### Year-by-year returns

This chart shows how Class A units of the Fund performed over the past 10 years. The Fund dropped in value in 2 of the 10 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



#### Best and worst 3-month returns

This table shows the best and worst returns for Class A units of the Fund in a 3-month period over the past 10 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

	Return	3 months ending	If you invested \$1,000 at the beginning of the period
Best return	10.64%	June 30, 2020	Your investment would rise to \$1,106.37
Worst return	-13.71%	March 31, 2020	Your investment would drop to \$862.91

#### Average return

The annual compounded return of Class A units of the Fund was 8.37% over the past 10 years. If you had invested \$1,000 in the Fund 10 years ago, your investment would now be worth \$2,234.46.



**Who is this Fund for?**

This Fund is suitable for investors who:

- want a core U.S. equity fund that focuses on investing in established corporations
- have longer term investment goals
- are comfortable with medium investment risk

This Fund may not be appropriate for an investor who needs regular income or stability of capital or is pursuing a short-term investment goal.

**A word about tax**

In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold the Fund in a non-registered account, Fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following table shows the fees and expenses you could pay to buy, own, and sell Class A units of the Fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

The fund is sold on a no-load basis only, **sales charges do not apply.**

**2. Fund expenses**

You don't pay these expenses directly. They affect you by reducing the Fund's returns.

For the year ended December 31, 2021, the Fund's expenses totaled 2.02% of its value. This is approximately \$20.20 for every \$1,000 invested.

**More about the trailing commission**

As the Class A units of the Fund are sold by Educators Financial Group on a no-load basis, there are no trailing commissions paid.

**3. Other fees**

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Short-term trading fee	1% of net asset value for units redeemed within 90 days of the date of purchase.
Account transfer fee	\$150 plus HST. This fee is charged when an account is closed and transferred to another financial institution.



### What if I change my mind?

Under securities law in Ontario and British Columbia, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In Ontario and British Columbia, you also have the right to cancel a purchase, or claim damages if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act with the time limit set by the securities law in your province.
