MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Risk

The impact of the coronavirus (*COVID-19*) pandemic on the financial performance of the Fund's investments will depend on future developments, including the duration and spread of the outbreak and related advisories and restrictions. This public health crisis and the impact of *COVID-19* on the financial markets and the overall economy are highly uncertain and cannot be predicted. If the financial markets and/or the overall economy are impacted for an extended period, the Fund's future investment results may be materially affected.

Results of Operations

The Fund's net assets decreased by 7.0% to \$78.4 million at the end of June 2022, down from \$84.3 million at the end of December 2021.

Investment Performance

For the year/period ending June 30, 2022 (the 'period'), the Educators Monitored Conservative Portfolio – Class A Series provided a negative return of 10.98% versus a Benchmark return of negative 10.74%. The Benchmark is a weighted composite consisting of 5.5% MSCI EAFE Index C\$, 6.5% S&P 500 Index C\$, 16.0% S&P/TSX Composite Index, 51.5% FTSE Canada Universe Bond Index, 15.5% FTSE Canada Short Term Bond Index, and 5.0% FTSE 91-Day T-Bill Index (the 'Benchmark').

The Fund underperformed its blended Benchmark over the period. Unlike the Benchmark, the Fund's return is net of fees and expenses paid by the Fund. Detailed performance is provided under the heading "Past Performance" in this report. Investors cannot invest in the Benchmark without incurring fees, expenses and commissions which are not reflected in Benchmark returns.

Contributions from the Fund's Canadian and U.S. equity holdings helped soften declines throughout this volatile period. The portfolio manager's asset allocation decisions also lessened the impact of negative returns, mainly due to the Fund's holdings in shorter-duration mortgages and an underweight position in government bonds. The portfolio manager continued these positions from last year to protect against the off chance that central banks would start an aggressive policy tightening cycle of raising rates, which turned out to be the case.

Within the equity segment of the Fund, the portfolio manager's preference for domestic over foreign stocks contributed to performance, although this impact was reduced after a poor showing from Canadian equities in the second quarter. During a challenging period for non-government fixed-income assets, the Fund's allocations in global high-yield bonds and emerging market bonds had a negative impact on performance compared to the index's relative returns. The Fund's holdings in Canadian bonds and international equities also underperformed.

The portfolio manager has moved to a more cautious allocation of assets in response to intensifying macroeconomic risks. Although the portfolio manager continues to have a small preference for equities over fixed-income assets, this is mainly expressed through the Fund's holdings in domestic equity markets, where valuations still look more attractive than those in other jurisdictions. The portfolio manager also believes that the Canadian equity market's exposure to companies in the energy and materials sectors can be advantageous in light of surging commodity prices.

Compared to the Benchmark, the Fund has a modestly higher position in U.S. equities and is broadly neutral-to-underweight in other global equity markets. Within fixed income, the Fund continues to have a lower-than- Benchmark weight in government bonds and emerging market bonds and a higher-than- Benchmark position in money market securities and mortgages. The portfolio manager is keeping the Fund's underweight position in global inflation-linked bonds, as these are vulnerable to policy rate hikes, as with any other government bonds, despite providing protection against inflation risks.

Recent Developments

The first six months of 2022 were characterized by moderating economic growth, high inflation, and interest rate hikes by central banks. The war in Ukraine and *COVID-19* have also disrupted supply chains, causing commodity prices to surge. Investment markets have been battered by these adverse shocks and there is a fair level of uncertainty about what happens next.

On balance, the portfolio manager sees Canadian investors weathering the current volatility better than most, based on several positive factors, namely, a strong job market, solid corporate earnings, and robust commodity prices. The Canadian employment picture is particularly encouraging, with approximately 0.8 jobs per unemployed person, a level not seen in recent history. These factors support the portfolio manager's view that Canada is not facing the prospects of a recession in the near-term.

Globally, the risk of recession has undoubtedly grown as interest rates rise towards restrictive levels and inflation squeezes consumer incomes. However, risks are higher for Europe versus the U.S., where the underlying strength of consumer demand and labour market growth is greater.

Overall, the portfolio manager expects global growth to be moderate, but remains positive, as they do not believe a global activity contraction is likely, so long as corporate earnings and labour markets remain strong. However, since the beginning of the year, inflation has increased and broadened out around the world, as external factors have caused prices to surge for energy and food items. This higher inflation may persist as long as supply-chain issues and rising wages continue to linger.

⁽⁵⁾ Management expense ratio is based on total expenses (excluding distributions, commissions, and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

⁽⁶⁾ The management expense ratio before waivers or absorptions shows what the management expense ratio of the Fund would have been if Educators Financial Group had not charged a lesser amount for its management fee.

⁽⁷⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁽⁸⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio manager manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.



Management Fees

Educators Financial Group is the Manager-Trustee, promoter, and principal distributor of the Fund, and is responsible for the day-to-day management and administration of the Fund.

The Manager-Trustee monitors and evaluates the performance of the Fund and pays for the investment management services of the portfolio manager, as well as all administrative services required by the Fund. As compensation for these services, Educators Financial Group is entitled to receive a fee, payable monthly and calculated daily, based on the Net Asset Value of the Fund, at the annual rate of 1.45% for the Class A Series, 1.16% for the Class E Series and 0.55% for the Class F Series. The Class I Series is identical in all aspects to the Class A Series, except that there is no management fee payable by the Fund in respect of the Class I units.

The Fund is responsible for paying any applicable tax owing on its management fee.

Approximately 15.3% of the total management fees collected from all Series were used to pay for portfolio management services, with the remainder of the fees being allocated to custodial services, marketing, technology, and Manager-Trustee operating expenses.

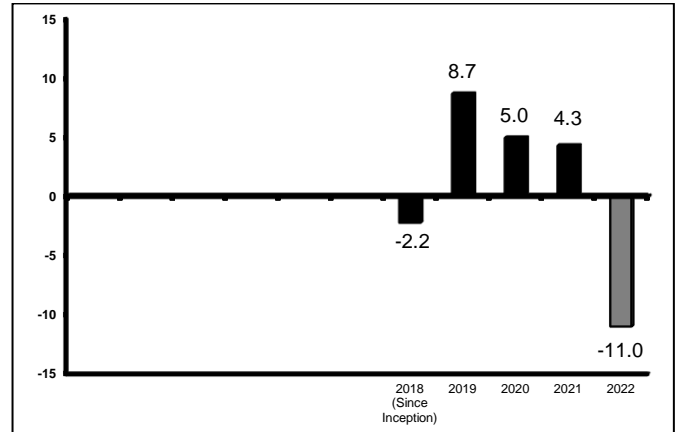

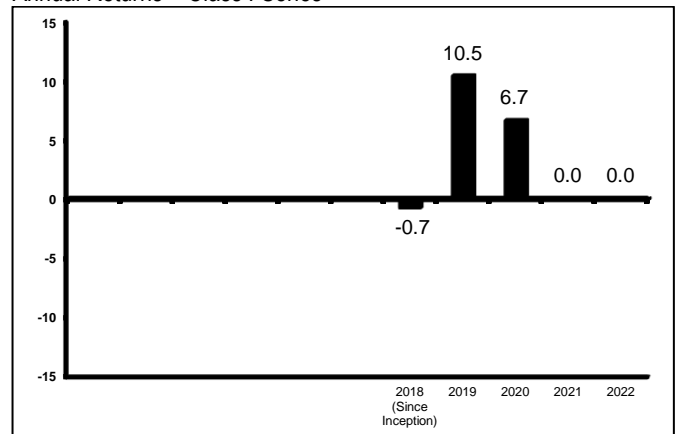
Year-by-Year Returns

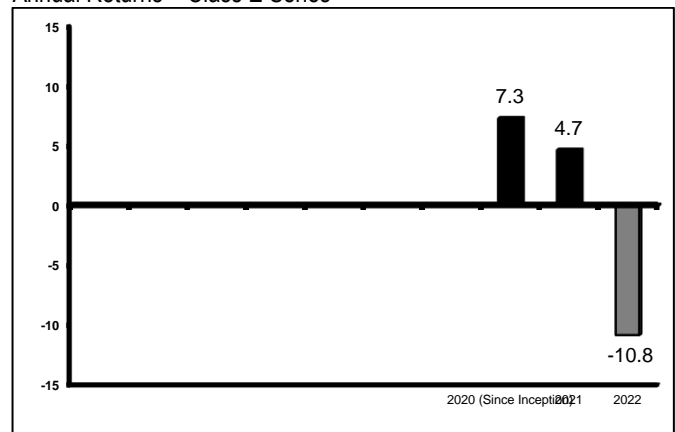
Annual Returns – Class A Series ⁽¹⁾



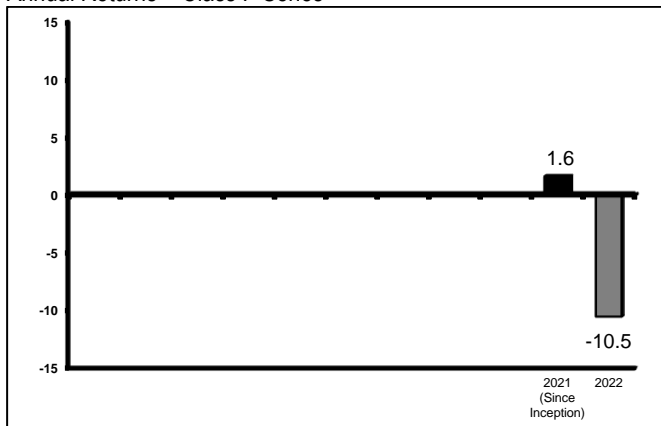
Annual Returns – Class I Series ⁽¹⁾
