This Fund invests primarily in mutual funds that invest in securities of Canadian and foreign governments and corporations. Up to 70% of the Fund may be invested in funds investing in foreign securities.


The charts below give you a snapshot of the Fund's investments on March 31, 2023. The Fund's investments will change.

How Risky is it?

Total number of investments:

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

No quarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

Risk rating

Educators Financial Group has rated the volatility of the Fund as low to medium.

Because this is a new fund, the risk is only an estimate by Educators Financial Group. Generally, the rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.





How has the Fund performed?

This section tells you how the Class E units of the Fund have performed over the past 2 years. Returns are after Fund expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how Class E units of the Fund performed in the past 2 years. The Fund dropped in value in 1 of the 2 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Class E units of the Fund in a 3-month period over the past 2 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

The annual compounded return of Class E units of the Fund was 7.76% over the past 2 years. If you had invested \$1,000 in the Fund 2 years ago, your investment would now be worth \$1,235.91.

How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account. |

How much does it cost?

The following table shows the fees and expenses you could pay to buy, own and sell Class E units of the Fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

The fund is sold on a no-load basis only, sales charges do not apply.

2. Fund expenses

You don't pay these expenses directly. They affect you by reducing the Fund's returns.

For the year ended December 31, 2022, the Fund's expenses totaled 1.59% of its value. This is approximately \$15.90 for every \$1,000 invested.
