What does the Fund invest in?

The investment objective of the Fund is to achieve moderate growth by investing primarily in a globally diversified portfolio of equity securities of companies that meet the ESG and impact related investment standards established for the Fund. The Fund may invest up to 100% of its assets in foreign securities.

The charts below give you a snapshot of the Fund's investments on January 17, 2024. The Fund's investments will change.

How Risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

No guarantees

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

Risk rating

Educators Financial Group has rated the volatility of the Fund as **medium.**

Because this is a new fund, the risk is only an estimate by Educators Financial Group. Generally, the rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a medium risk rating can still lose money.

How has the Fund performed?

This section tells you how the Class A units of the Fund have performed over the past year. Returns are after Fund expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

Who is this Fund for?

This Fund is suitable for investors who:

- Have a long-term investment time horizon
- Want to achieve long-term capital growth
- Want a Global plus Canadian equity fund that focuses on investing in established companies
- Have ESG-related investment objectives
- Are comfortable with a medium investment risk

This Fund may not be appropriate for an investor who needs regular income or stability of principal, or is pursuing a short-term investment goal.

A word about tax

In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold the Fund in a non-registered account, Fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following table shows the fees and expenses you could pay to buy, own and sell Class A units of the Fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

The fund is sold on a no-load basis only, sales charges do not apply.

2. Fund expenses

You don't pay these expenses directly. They affect you by reducing the Fund's returns.

The fund's expenses are made up of its management fee, operating expenses and trading costs. The management fee for the Class A units is 2.00% per year of their value. Since the Fund and the Class A units are newly created, operating expenses and trading cost information is not available.

More about the trailing commission

As the Class A units of the Fund are sold by Educators Financial Group on a no-load basis, there are no trailing commissions paid.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Short-term trading fee	1% of net asset value for units redeemed within 90 days of the date of purchase.
Account transfer fee	\$150 plus HST. This fee is charged when an account is closed and transferred to another financial institution.

What if I change my mind?

Under securities law in Ontario and British Columbia, you have the right to:

- withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In Ontario and British Columbia, you also have the right to cancel a purchase, or claim damages if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act with the time limit set by the securities law in your province.
