MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

The Fund's net assets increased by 7.4% to \$127.8 million at the end of June 2024, up from \$119.0 million at the end of December 2023.

Investment Performance

For the year/period ending June 30, 2024 (*the period*), the Educators Growth Fund – Class A Series provided a return of 7.76% versus the S&P/TSX Composite Total Return Index (*the Benchmark*) return of 6.05%.

The Fund outperformed its Benchmark over the period. Unlike the Benchmark, the Fund's return is net of fees and expenses paid by the Fund. Detailed performance is provided under the heading "Past Performance" in this report. Investors cannot invest in the Benchmark without incurring fees, expenses and commissions which are not reflected in Benchmark returns.

Market performance was positive throughout the first few months of 2024, though technology stocks, which had outperformed in 2023, abated—and commodity stocks led the way, reflecting rising prices and more resilient geopolitical uncertainty. During the second quarter, the rally abated, as concerns around declining productivity in Canada became more pronounced. Despite the first interest rate cut by the Bank of Canada in June, the Canadian stock market had its first negative quarter since late 2023, as most non-resource heavy sectors had negative returns for the period.

The Fund outperformed its benchmark during the period, benefitting from positive relative contributions in most sectors—particularly in the Information Technology, Consumer Discretionary, and Financials sectors. Within the Information Technology sector, the greatest contributions came from security selection, including holdings of Constellation Software and Descartes Systems, as well as not holding Shopify Inc., which underperformed compared to its peers. The Fund's holdings in the Information Technology sector continue to be directed to companies providing mission critical IT products, which lead to more stable and predictable income streams.

Within the Consumer Discretionary sector, holdings of Dollarama continued to enhance performance during the period. Dollarama is a provider of general merchandise through their network of discount retail stores located throughout Canada. The company has a culture of efficiency led by an experienced management team, with the founding family still retaining a minority ownership stake. Their stores continue to be a trusted destination for consumers and their basic needs. The company has shown resiliency in managing inflationary and supply chain pressures, while continuing to open new stores and focus on optimizing their product offering. The company once again reported growing profit, stemming primarily from household goods and consumables. Furthermore, Dollarama has opened 62 stores over the last 12 months and recently announced they are increasing their stake in Latin American retailer Dollarcity.

Notable contributors within the Financials sector included TMX Group Limited, Toronto Dominion Bank, Intact Financial, and the Bank of Nova Scotia. The Fund's underweight position in both the Energy and Materials sectors detracted from performance, as did holdings of CGI Inc. and TELUS Corp. After performing well in 2023, CGI has seen a slowdown in new implementations, as clients have exercised caution in their spending and opted to delay certain capital expenditure decisions. The portfolio adviser continues to have conviction in the company, as they have continued to reinvest in the business and integrate and leverage AI, both internally and in their service offering.

During the period, the portfolio adviser sold the Fund's positions of Richelieu Hardware and Winpak, and redeployed the proceeds into existing positions. Positions that were increased included Industrial Alliance, a position the portfolio adviser has been building up since adding it to the Fund in Q3 2023, and RB Global (*previously named Ritchie Bros. Auctioneers*), where the adviser's conviction in the company has increased following their purchase of IAA Inc. in late March.

Recent Developments

The Canadian equity market has continued to perform positively in the first few days of the third quarter. Market sentiment has remained strong, despite weakness in recent data releases, including Canadian June employment data and in both manufacturing and services' Purchasing Managers' Index (*PMI*). Based on the economic and earnings data released thus far in July, the portfolio manager has maintained their equity positioning and will continue to focus on a selection of companies that can withstand tough times and are currently trading at an attractive discount to their intrinsic value. These characteristics are expected to position the portfolio well for long-term compounding of returns.

The ebb and flow of rate cut expectations in both the U.S. and Canada continues to dominate market sentiment in 2024, as it did in 2023. Slow, but definitive progress on inflation eventually produced the first Canadian cut of the cycle in June, while U.S. central bank officials have yet to act. Inflation in both countries is still above the two central banks' common target of 2.00%, but the achievement of that level in both markets now appears to be likely in 2025. Despite the reluctance of policy makers to lower rates, economic growth has proved resilient, and the prospect of a recession has diminished. Slow growth and continued improvement on inflation should provide an environment conducive to less restrictive policy, with a consensus view of cuts by 50-basis points in both markets for the remainder of 2024.

Related Party Transactions

In the first six months of 2024 Educators Financial Group did not refer any conflict of interest matters to the Fund's Independent Review Committee (*the IRC*) and accordingly did not rely upon any

recommendation of the IRC in respect of any related party transactions.

Educators Financial Group is the Manager and Trustee of the Fund. Educators Financial Group is a wholly owned subsidiary of the Ontario Secondary School Teachers' Federation (*OSSTF*). OSSTF may from time to time invest in units of the Fund.

⁽²⁾ Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of units outstanding over the financial period. This table is not intended to be a reconciliation of beginning to ending net assets per unit.

⁽⁵⁾ Management expense ratio is based on total expenses (excluding [distributions], commissions, and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of daily average net asset value during the period.

⁽⁶⁾ The management expense ratio before waivers or absorptions shows what the management expense ratio of the Fund would have been if Educators Financial Group had not charged a lesser amount for its management fee.

⁽⁷⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

⁽⁸⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

Educators Financial Group is the Manager-Trustee, promoter, and principal distributor of the Fund, and is responsible for the day-to-day management and administration of the Fund.

The Manager-Trustee monitors and evaluates the performance of the Fund and pays for the investment management services of the portfolio adviser, as well as all administrative services required by the Fund. As compensation for these services, Educators Financial Group is entitled to receive a fee, payable monthly and calculated daily, based on the Net Asset Value of the Fund, at the annual rate of 1.75% for the Class A Series and 0.75% for the Class F Series. The Class I Series is identical in all aspects to the Class A Series, except that there is no management fee payable by the Fund in respect of the Class I units.

The Fund is responsible for paying any applicable tax owing on its management fee.

Approximately 19.4% of the total management fees collected from all Series (excluding Class I Series approximately 15.7% of the total management fees collected), were used to pay for portfolio management services, with the remainder of the fees being allocated to custodial services, marketing, technology, and Manager-Trustee operating expenses.

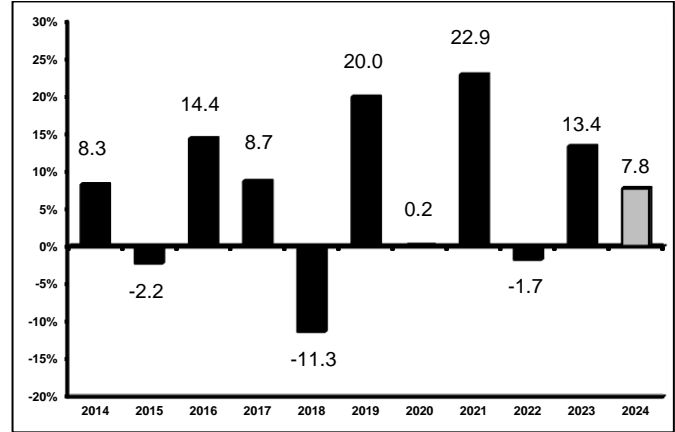

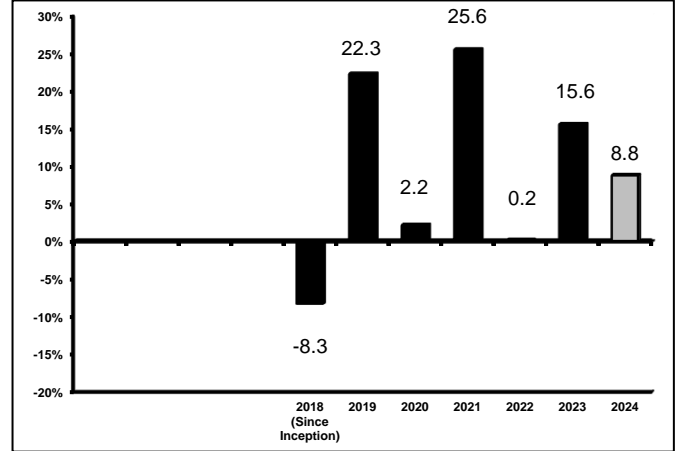
Year-by-Year Returns

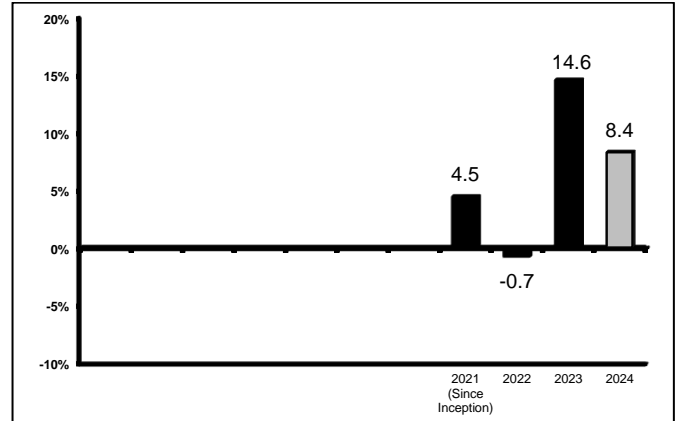
Annual Returns – Class A Series
